For Federal Income Tax purposes, dues payments to the Gilmer County Home Builders Association are not deductible as charitable contributions. However, dues may be deductible as ordinary and necessary business expense, subject to exclusions for lobbying activity. Contributions to the Builders Political Action Committee (BPAC) are not tax deductible.

**In 2009 14% of the \$150.00 NAHB dues are used for lobbying, so \$21.00 of those dues are not deductible for 2009.**  
(In 2008, 12% of the \$150.00 NAHB dues were used for lobbying, so \$18.00 of those dues were not deductible for 2008.)

**In 2009, 50% of the \$75.00 HBAG dues are used for lobbying, so \$37.50 of those dues are not deductible for 2009.**  
(In 2008, 36% of the \$75.00 HBAG dues were used for lobbying, so \$27.00 of those dues were not deductible for 2008)
